Re: Dismissal of my complaint about Fiona Seaton, solicitor

As you are aware, Fiona Seaton wrote to DG Thompson Lawyers on 17th February 2017 alleging that I had partaken in criminal conduct and also falsely stated that I was a dangerous individual with a documented history of violence. On being made aware of such, a complaint was made to your office.

The matter was passed to the Law Society to 'investigate'. During such 'investigation', Ms Seaton repeated her untrue accusations as well as alleging, among other things, that I befriend elderly women in order to take their monies.

None of the above was in any way substantiated and the Law Society at no time requested of Fiona Seaton to provide the basis for her false claims about me. The said documented history of violence was never produced, despite a number of requests by me to do so.

In my responses to the above, it was demonstrated quite clearly that the allegations as made by Fiona Seaton were indeed untrue and that the Law Society had also been misled.

As you can see from the **attached** letter which I received from the Law Society yesterday evening (dated 9th October 2017), the Law Society has dismissed my complaints about Fiona Seaton and has considered my complaints to be '*misconceived or lacking in substance*'.

The Law Society has not provided any explanation as to why it considers my complaints to be '*misconceived or lacking substance*', despite the fact that my complaints are in no way '*misconceived or lacking in substance*'.

In my mind, it was a foregone conclusion that my complaints about Fiona Seaton would be dismissed as the matter involved Turner Freeman Lawyers.

It is of note that during the supposed 'investigation' by the Law Society regarding my complaints about Fiona Seaton, evidence of fraud was provided to the Law Society regarding the conduct of another solicitor at Turner Freeman Lawyers. This evidence of fraud was ignored.

As we have seen, Turner Freeman Lawyers is able to carry out any misdeeds it wants, including fraud, with the Law Society and your office turning a very distinct and obvious blind eye.

The corruption involved in this matter, as that is what it is, is now so obvious that it is clearly undeniable and the only question remaining is why solicitors from one particular law firm can behave in any fashion they please with your office and the Law Society 'going out on a limb' to protect them. I defy you to deny that such is the case.


